



Agreement to Use Facilities and Services Provided and Waiver of Liability

As Consideration for being allowed to enter the play area/or participate in any party and /or program at Fun Bugs Playground the undersigned, on his or her behalf, and on the behalf of the Participatint(s) identified below, acknowledges, appreciates, understands, and agrees to the following :

• I understand that inherent risk of injury or illness, though minimal, does exist. • I and the children have no illness or injury that may affect the safe enjoyment of Fun Bugs Playground by us or other guests. • I, for myself and the children, knowingly and freely assume full responsibility for my and the children’s participation at Fun Bugs Playground and freely assume all risks, both known and unknown, even if arising or resulting from negligence of Fun Bugs Playground staff or others. • I and the children willingly agree to comply with the stated terms and conditions for participation and to obey the directions of and requests of Fun Bugs staff. • I, for myself and the children, agree to the following safety rules:

- **No Bare Feet – Socks are Mandatory and Children remain the responsibility of their accompanying adult at all times**
- **An attending adult must remain on the premises at all times for children under the age of 6 and under**
- **No gum, food or drink in the play areas, designated areas only**
- **No climbing the slides or No climbing on the outside of the structure**
- **No hooded sweaters or clothing with drawstrings that could get caught**
- **Please report any inappropriate behavior to a Fun Bug’s staff member**
- **Fun Bug’s reserves the right to refuse admission and request any person to leave the premises**
- **Fun Bug’s is not responsible for any lost or stolen items**
- **No party celebrations allowed in common area (i.e. cakes, gift opening, etc.)**
- **Please no personal food deliveries to Fun Bugs Playground**

• I have ensured the children are aware of the above safety rules.

• I, for myself, the children and on behalf of my and their heirs, assigns, personal representatives and next Of kin, hereby waive, release and discharge Fun Bugs Playground and its directors, officers, agents, Employees, owners and representatives (collectively ‘Fun Bugs’) with respect to any and all losses, Damages, injuries, expenses and claims, including without limitation suffered or incurred as a result of the children using Fun Bugs Playground, due to any cause whatsoever, for personal injury, death or loss or damage to person or property, even if arising from the negligence of Fun Bugs or otherwise and hereby agree to indemnify and hold harmless Fun Bugs from and against any liability, losses, claims and damages resulting from the children using Fun Bugs Playground.
